# B. Approval of Minutes

Motion by Mr. Kuchta, seconded by Mr. Lykins, to approve the minutes of the October 14, 2016, Regular meeting of the Clermont County Transportation Improvement District, as submitted, upon roll call vote, carried with members present voting aye.

# C. Transportation Improvement Projects Progress Updates

- 1. **OKI/ICC Update** Bob Koehler, OKI, advised that they are preparing for their federal certification review on Tuesday and Wednesday and that there are no other new updates.
- 2. Eastern Corridor Segments I, II-III, IVa, and Oasis Line Charles Rowe, ODOT, advised that on Segment I, the Duck Creek Connector project site was cleared and permits were updated to reflect MSD requirements. On the Red Bank/Madison, Babson/Hetzel Connector, AECOM is revising traffic studies to reflect comments from ODOT and the City and a meeting to discuss the information will be held in mid-January. The Red Bank/Erie/Brotherton project is still on hold pending additional funding and prioritization by the City. On Segment II/III, Stantec submitted draft needs analysis documents on December 7<sup>th</sup>. ODOT is in the process of reviewing the materials and will be transmitting the information to Partners this month. They will be setting up meetings to go over any comments that they may have. A public involvement meeting will be scheduled in early 2017. On Segment IVa, the design for the eastbound 3<sup>rd</sup> lane is continuing. Fee negotiations for Old SR 74 Phase 2, the proposed interchange and Bach Buxton relocation is on-going. ODOT hopes to have a consultant authorized in early 2017. ODOT received safety funds to make improvement to southbound 275 and 32 interchange. They plan to extend the exit ramp up 2000 feet and make it a dual exit.
- **3.** Old SR 74 Widening Phase I Craig Stephenson, CCEO, advised that items 3 and 4 are part of Segment IVa. Mr. Stephenson advised that plans were submitted to ODOT for review of ROW.
- **4.** Clepper Lane Extension Craig Stephenson, CCEO, advised that they are still in ROW plan development.
- 5. Aicholtz Connector Doug Royer, CCEO, advised that the contractor is making good progress.
- 6. Eastgate Area Community Outreach Betty Hull, RMC, advised that the newsletter is under review. There has been increased social media regarding Old SR 74 and South Afton. Rasor continues website monitoring and updates, community outreach, public feedback and media relations work.
- 7. Old SR 74 Widening Olive Branch-Stonelick to Armstrong Blvd. Doug Royer, CCEO, advised that a section of AOB and Olive Branch Stonelick is closed. The contractor has completed the water main and sanitary sewer work and will begin construction on the bridge and retaining wall work.
- **8.** Eastgate South Drive Extension Jeremy Evans, CCEO, advised that the project is complete. There is a new business item on the agenda relative to the final costs on the project. We are in the process of finalizing paperwork for the close-out.
- 9. Wolfpen/Pleasant Hill Road Safety Improvements Doug Royer, CCEO, advised that the contractor has completed much of the wall work and will continue the work over the winter months. Mr. Royer advised that there has been lots of progress on the project.
- 10. Branch Hill Guinea Pike at Jer-Les Drive Nick Yeretzian, Kleingers, advised that they have submitted the final construction and ROW documents to the County.
- 11. Aicholtz Road Widening Frank Aransky, American Structurepoint, advised that they continue Stage 1 plan development. Mr. Aransky anticipates that in December they will finalize horizontal and vertical geometry work, preliminary pavement design, preliminary storm water design and finalize storm water plans for Echelon development outlet.

- **12. Clermont County Airport** Doug Royer, CCEO, advised that PB has the aerial work finished. Next week they will do the ground survey. The next phase will be to submit a letter and studies to the FAA. The FAA will then instruct what the next steps will be.
- 13. South Afton Commerce Park Jeremy Evans, CCEO, advised that the contractor has the road built up to the subgrade level and they are waiting for the ground to freeze to put a gravel base down to have access to the site. The contractor will continue to work on the water and sanitary sewer as long as the weather permits.
- 14. SR 32 Improvements at Bell's Lane Steve Shadix, Stantec, advised that Stage 1 plans have been submitted and they are waiting on comments back from ODOT and the County. They are also waiting on certified traffic back from ODOT.
- **15.** West Clermont Area Improvements Jeremy Evans, CCEO, advised that plans are complete and that the project will be under construction in early 2017.
- **16. Shayler at Bach-Buxton Intersection Improvements** Jeremy Evans, CCEO, advised that Choice One Engineering has submitted preliminary plans.
- 17. Chapel Woods Drive Bridge Craig Stephenson, CCEO, advised that they have received OPWC emergency funds for the project. The project will be under construction in early 2017.
- 18. Johnson Road Bridge Replacement Craig Stephenson, CCEO, advised that the contract for the project will be signed today. The contractor will begin work by tearing out the old bridge and the bulk of the work on the project will be completed in the spring and summer of 2017.
